

ZERO REFLEX CONTEST RULES

CONTEST TERMS AND CONDITIONS

- These terms and conditions together with any specific rules set out in Contest Notices (as defined below) are the Contest Rules ("Rules") and apply to contests ("Contest") featuring any Zero Reflex version of the game unless otherwise expressively stated. By entering a Contest, entrants agree to be bound by these Rules.
- Rules specific to each Contest are displayed in the latest version of the game under the info button and each
 platforms store Zero Reflex version description ("Contest Notice") or in a notice in which the Contest appeared and
 are incorporated into the Rules. In the event of discrepancy between these terms and conditions and the Contest
 Notice, the Contest Notice shall prevail.
- 3. Adminde reserves the right to cancel or amend the Contest or the Rules without notice in the event of a catastrophe, war, civil or military disturbance, act of God or any actual or anticipated breach of any applicable law or regulation or any other event outside Adminde's reasonable control. Any changes will be posted either within these terms and conditions or the Contest Notice. A copy of the Rules may also be obtained by contacting the relevant department of the platform store in which the contest appeared.
- 4. In the event of any dispute regarding the Rules, conduct, results and all other matters relating to a Contest, the decision of Adminde shall be final and no correspondence or discussion shall be entered into.

QUALIFYING ENTRANTS

- 5. To qualify to enter the Contest you must be a resident of countries in which it is legal to organize such contest and win prizes based on such contests.
- 6. Employees of Adminde or any associated company of Adminde and their immediate families, persons connected with the contest/prize draw and their immediate families i.e. prize sponsors, newsagents, wholesalers & their agents are not eligible to enter the Contest.
- 7. Additional eligibility requirements may apply to a specific Contest, e.g. a valid passport, visas and/or driver's licence will be required if the Contest prize includes travel outside the United Kingdom and/or car hire.
- 8. By entering the Contest, you hereby warrant that all information submitted by you is true, current and complete. Adminde reserves the right to verify the eligibility of all entrants.
- 9. Adminde assumes that by playing the game or by using the website and entering the Contest (and you warrant that) you are aged 18 or over or, if you are under 18, that your parents have consented to your entry into the Contest and these Rules.
- 10. Adminde reserves the right to disqualify any entrant if it has reasonable grounds to believe the entrant has breached any of the Rules.
- 11. In the event that any entrant is disqualified from the Competition, Adminde in its sole discretion may decide whether a replacement should be selected. In this event, any further entrant will be selected on the same criteria as the original entrant and will be subject to these Rules.



HOW IT WORKS

- 12. Every qualifying entrant can enter the Contest by playing a legal copy of Zero Reflex purchased through any of the platform stores (App Store, Play Store, Windows Phone Store or Steam).
- 13. The first global player to finish the game in all its 60 challenges without cheating or hacking will be given the option to contact Adminde. Each entry of a finished game will be examined by Adminde. When Adminde establishes that the entry of a finished game was achieved without any cheating or hacking the winner will be announced and contacted.

PRIZES

- 14. One grand prize winner will receive \$10,000 transferred to his PayPal account. All expenses not specifically provided for herein are the winner's sole responsibility. Some restrictions may apply.
- 15. Federal, state and local taxes, if any, are the sole responsibility of the winner. Winners are not entitled to exchange or transfer prizes or to obtain cash or other substitutes, but Adminde in its sole discretion may substitute prizes of equal or greater value.

RELEASES

- 16. By participating, entrants agree to be bound by these official rules and the decisions of Adminde, which shall be final in all respects.
- 17. By participating in the Contest and accepting any prize that they may win, entrants agree to release Adminde, their parent, subsidiary, affiliated and successor companies, advertising and promotion agencies and prize suppliers, and each of their respective officers, directors, agents, representatives and employees, as well as each of their respective successors, representatives and assigns (collectively, the "Released Parties") from any and all actions, claims, injury, loss or damage arising in any manner, directly or indirectly, from participation in this Contest and/or acceptance or use of the prize.
- 18. Entrants authorize the Released Parties to use their name, voice, likeness, biographical data, city and state of residence and entry materials in programming or promotional material, worldwide in perpetuity, or on a winner's list, if applicable, without further compensation unless prohibited by law. Adminde is not obligated to use any of the above mentioned information or materials, but may do so and may edit such information or materials, at Adminde's sole discretion, without further obligation or compensation.
- 19. To claim prize: (a) winner must provide proof of age, identity and residency; (b) winner must sign and return affidavit of eligibility/compliance with rules, publicity/liability release and indemnification; all within the time period specified by Adminde.

MISCELLANEOUS

Adminde reserves the right, in its sole discretion, to disqualify any individual who tampers with the entry process and to cancel, terminate, modify and/or suspend the Contest in the event of tampering or other circumstances, including but not limited to acts of God or civil disturbance that render it impractical or impossible to complete or fulfill the contest as originally planned.
- 22. The Competition and Rules will be governed by English law and any disputes will be subject to the exclusive jurisdiction of the courts of England.
